- 1. Meeting began at 8:45 EST. Board members present (see above). Board members absent: Tina Wismer, Amy Balthrop, KC Artley
- 2. Discussion of procedure to replace a board member retiring mid-term. KC Artley is retiring from the board after the Annual Membership meeting in May.
